## **Snodgrass featured at Outlook**

Eric Snodgrass, principal atmospheric scientist for Nutrien Ag Solutions and adjunct assistant professor at the University of Illinois, will be the featured speaker on Thursday, March 14, at Lavender Crest Winery, 5401 U.S. Highway 6, Colona. The evening will begin with a buffet dinner at 6:15 p.m., followed by an update from Gold Star FS Grain Merchandiser, Mike Schaver. Reservations must made by March 7 to guarantee a meal.

At Nutrien Ag Solutions, Snodgrass develops predictive, analytical software solutions to manage weather risk for global production agriculture. He provides frequent weather updates that focus on how high-impact weather events influence global agriculture productivity. His current research uses machine learning to better understand field-level weather impacts on yields in the U.S. and to increase confidence in long-range weather prediction. He presents his research as a featured speaker at over 50 conferences annually, where he provides logistical guidance and solutions to weather-sensitive financial institutions, farmers, commodity traders, and other stakeholders.

Before transitioning to Nutrien Ag Solutions, Snodgrass was the director of undergraduate studies for the Department of Atmospheric Sciences at the University of Illinois at Urbana-

Champaign from 2006-2019. Each year, he guided over 1,800 students through the wild side of weather in ATMS 120: Severe and Hazardous Weather.

He taught advanced courses on General Physical Meteorology (ATMS 201), Meteorological Instrumentation (ATMS 315), Economics of Weather (ATMS 491) and supervised numerous Capstone Research projects. Snodgrass also taught ENSU 310: Renewable and Alternative Energy for the Environmental Sustainability Program. He also advised all undergraduate majors and minors in atmospheric science (about 100 students) and supervised graduate teaching assistants and master's students.

He won many prestigious teaching awards at the University of Illinois including College of Liberal Arts and Sciences Teaching Excellence award, the Campus Teaching Excellence Award, and the Campus Teaching Excellent Award in Online and Distance Education. Also, his online version of ATMS 120 was awarded the 2012 "Best Online Course" from the University Professional Continuing Education Association (a national organization). Eric is now an adjunct assistant professor for the Department of Atmospheric Science at the University of Illinois

We are fortunate to offer several scholarships this year.

The RICFB Foundation scholarships are available only to high school seniors.

These scholarships have been established by the Rock Island County Farm Bureau Foundation and are supported through generous contributions from local families. Applicant must be a member or dependent of a member in good standing of the Rock Island County Farm Bureau since January 2018. Applicant can be majoring in any field; major does not have to be ag-related. The Wilbert and Carol Keppy **Scholarship** is open to graduating high school seniors as well as college students. Scholarship applications will be judged separately, however, applicant can only win one scholarship from the RICFB Foundation per year. NOTE: An applicant can only win one Keppy scholarship per year and previous Keppy Scholarship winners are ineligible from receiving future Keppy Scholarship funds. Criteria for selection will be achievements in agriculture activities, including an essay, leadership

in school and the community, scholastic achievement and financial need.

The Bernice E. Fowler Scholarship is open to a Rockridge High School graduating senior or graduate who is pursuing a degree in the education field. Bernice E. Fowler taught for 11 years in an Illinois City one-room schoolhouse. She continued teaching second grade at Grant School in Moline, where she retired with a 25-year teaching career. This scholarship has been established by her son and will yield a \$1,000 scholarship each year beginning in May 2013.
