

The Rock Island County Farm Bureau was recognized for its achievements during the 100th annual meeting of the Illinois Farm Bureau held in Chicago on Dec. 6-9, 2014

A member of Membership Group V, Rock Island County received bronze awards for the following programs: Membership Quota; Ag Literacy; Legislative/ Political Process; Member Relations; and Policy Development.

County Farm Bureaus in Membership Group V are those with 5,621 and more members. Rock Island County's total membership is 5,800, with 628 farmer

members.

As part of its Annual Meeting, Illinois Farm Bureau presents program and committee awards in recognition of outstanding county Farm Bureau volunteer efforts throughout the year.

The Illinois Farm Bureau is a member of the American Farm Bureau Federation, a national organization of farmers and ranchers.

Founded in 1916, IFB is a non-profit, membership organization controlled by farmers who join through their county Farm Bureau. IFB represents two out of three Illinois farmers.

\$7,000 in scholarships available

The Rock Island County Farm Bureau Foundation is proud to announce the 2015 Foundation Scholarship Program. Applications for the scholarships are due to the Farm Bureau office in Moline until 4 p.m. March 27.

Applications are available at www.ricofarmbureau.org. New this year – applicants can apply online and email more information as requested in the application.

The Rock Island County Farm Bureau Foundation will be awarding three \$1,000 scholarships. These scholarships have been established by the Rock Island County Farm Bureau Foundation and are supported through generous contributions from local families. The applicant must be a high school senior. Applicant must be a member or dependent of a member in good standing of the Rock Island County Farm Bureau since January 2014.

Applicant can be majoring in any field; major does not have to be agrelated.

Applicants may apply for the Rock Island County Farm Bureau Foundation Scholarship, as well as the Keppy Scholarship. Scholarship applications will be judged separately, however, applicant can only win one scholarship from the RICFB Foundation per year. NOTE: An applicant can only win one Keppy scholarship per year and previous Keppy Scholarship winners are ineligible from receiving future Keppy Scholarship funds. Criteria for selection will be achievements in agriculture activities, including an essay, leadership in school and the community, scholastic achievement and financial need.

The Rock Island County Farm Bureau Foundation also awards two scholarships for the Wilbert and Carol Keppy Foundation. Applicants may be a graduating high school senior or student currently enrolled in an undergraduate college degree program.

Rockridge H.S. scholarship

This scholarship is open to a Rockridge High School graduating senior or graduate who is pursuing a degree of study in the education field. Bernice E. Fowler taught for 11 years in an Illinois City one-room school house. She continued teaching second grade at Grant School in Moline, where she retired from a 25-year teaching career. This scholarship has been established by her son and will yield a \$1,000 scholarship each year.
