All women involved in farming and the agriculture industry are encouraged to attend the Women in Agriculture Conference, Friday, March 27, 2020, at Jumer's Casino and Hotel in Moline, Illinois. This one-day seminar empowers women within agriculture industries.

This conference, celebrating its ninth year, will feature keynote speaker

Jeanne Bernick. Bernick is an agribusiness consultant and market Growth Leader for national business advisory firm K-Coe Isom. She offers a depth of industry insights and works alongside clients



that help keep their farms and businesses not just viable but thriving. Her presentation, "How Women Change the World One Farm at a Time," will focus on how the world is changing for the better as more women are coming back to their agricultural roots. Bernick will provide tips and tricks on leading as a woman working in agriculture. She also co-authored the book "Ceres Rising: How Women are Leading Farm
