Vote against the progressive tax

We urge all voters to defeat the proposed Constitutional Amendment question that will be on the November ballot. If enacted, this amendment would end our state's flat income tax and will roll into place a progressive income tax. But we believe there is nothing fair about a progressive tax – a tax that shifts the state's financial burdens onto the most successful businessmen men and women. Vote no on the Constitutional Amendment to keep our state's income tax flat and fair.

Illinois' current non-graduated, or flat, income tax of 4.95 percent fairly applies the same tax rate to everyone in the state. Compare that to the proposed progressive tax. If the amendment is approved by voters in November, a progressive income tax rate structure already agreed to by lawmakers - would take effect. This progressive income tax structure divides Illinoisans into categories based on their level of income, and, as income levels get progressively higher so do the tax rates. Under this progressive income tax structure, the tax rates start at 4.75 percent and go all the way up to 7.99 percent.

Since the 1970s, Illinois' Constitution has ensured that all Illinoisans "equally" pay the same income tax rate. This means if the tax rate increases for one person it increases for all—this is fair. But under a progressive income tax, lawmakers can pick and choose whose taxes they raise. With a single bill, state lawmaker can adjust these income categories and raise the tax rates on any and all of us.

Grain bin safety program set

The Rock Island and Mercer County Farm Bureaus are partnering with the Illinois Fire Service Institute and Sherrard FFA to host "Farmers and First Responders," a grain bin safety program on Saturday, Sept. 12, at Sherrard High School, 4701 176th Ave., Sherrard, IL. The program will begin at 9 a.m. with a hands-on, live simulation grain bin entrapment demonstration provided by the Illinois Fire Service Institute. Lunch will be served at noon, followed by a showing of the movie "Silo" at 1 p.m.

"Silo" is the first-ever featured film about grain entrapment. Inspired by true events, "Silo" follows a harrowing day in an American farm town. Disaster strikes when teenager Cody Rose is entrapped in a 50-foot-tall grain bin. When the corn turns to quicksand, family, neighbors and first responders must put aside their differences to rescue Cody from drowning in the crop that has sustained their community for generations. Free recycling program offered

SPRINGFIELD, Ill. - The Illinois Department of Agriculture is encouraging farmers and agrichemical facilities to save their empty agrichemical containers as they will once again be hosting free container recycling days

Beginning the middle of July and continuing into August, sites throughout the state will collect the empty containers which will be recycled and made into shipping pallets, plastic lumber, and other useful products.

In 2019, 30 single-day collection events were held throughout the state. IDOA personnel inspected and collected approximately 95,000 pounds of

#2 HDPE plastic pesticide containers from pesticide users.

"This program offers farmers and agrichemical facilities a convenient opportunity to dispose of empty pesticide containers while also helping to protect the environment," said Jerry Costello II, director of the IDOA. "I encourage farmers to gather any containers they may have been planning to throw out and take them to the nearest collection site to be repurposed."

Metal and household pesticide containers are not eligible for the recycling

Collection sites will accept only high-density polyethylene, #2 plastic agrichemical containers that are clean and dry. Participants are responsible for rinsing them and removing all caps, labels, booklets, and foil seals.

The program is a cooperative venture between the Illinois Department of Agriculture, Agriculture Container Recycling Council, GROWMARK, Inc., Illinois Fertilizer and Chemical Association, G. Phillips and Sons, L.L.C., Illinois Farm Bureau, and the University of Illinois Extension.


